## 1.4. Public Policy at IIT Bombay

The Ashank Desai Centre for Policy Studies (ADCPS, previously Centre for Policy Studies) at Indian Institute of Technology (IIT) Bombay was established in 2016 to advance rigorous research, interdisciplinary teaching, and public engagement in the field of public policy. The Centre began its academic journey with the launch of its PhD in Public Policy programme in 2017, followed by the Master of Public Policy (MPP) programme in 2019. In 2021, it was renamed in honour of Mr Ashank Desai, an IIT Bombay alumnus and philanthropist, whose generous support has helped strengthen the Centre's vision and capacity. As ADCPS welcomes the 9th cohort of its PhD programme in 2025, it continues to grow as a platform where academic rigour meets public relevance, committed to nurturing scholars rooted in democratic values and attentive to structural realities and global transformations.

The Centre engages with complex policy problems by drawing on integrated perspectives from the fields of Social Science, Science & Technology, Law, and Medicine. Research at ADCPS is organised around five core thematic areas:

#### Digital Society & Governance

A broad political economy and political philosophy engagement with issues such as privacy, data localisation and ownership, e-commerce, etc.

### · Social Policy (Education, Ageing, Identity)

Responding to a lack of policy analysis through the lenses of gender, caste and age; in the context of economic growth and increased precarity.

### Technology & Policy

Closely examining the evolving and dynamic relationships between science, technology and society, in the context of policy making.

### Urban Policy

Faculty at ADCPS focus on various aspects of India's urban policy, including residential segregation, services, ageing, labour, and housing. India has seen

significant growth in its urban population over the past few decades, resulting in both challenges and opportunities.

#### · Water, Sanitation, Energy, Climate Change

The staggering challenges of protecting the ecology from climate changes seem to grow bigger as market-centric solutions have primacy in setting the policy agendas. ADCPS re-imagines the concerns of the 'environment' as a trigger for holistic attention to cross-cutting policy issues such as water, health, energy, migration & urbanisation.



# PhD Programme at a Glance



### 3.1. PhD Coursework

Coursework is mandatory in the first year of the PhD programme, which is divided into Autumn (Odd) and Spring (Even) semesters, respectively running from July to November and January to April. Both the semesters emphasise theoretical grounding through core courses in public policy theory and research methods. PhD students could choose from the wide variety of Department and Institute Elective Courses offered at ADCPS and the Institute-level, respectively, apart from the mandatory Core Courses. Additionally, PhD students are expected to prepare and present Credit Seminars in each of the semesters in the first year, in consultation with the guide. The expected outcome of the seminars could be to conduct literature reviews on the topic of choice or whichever project the PhD student and the guide decide to pursue in consultation with each other.

# 3.2. Types of Courses

Mandatory Credit Courses			
Core Courses	Foundational courses required by the Centre, covering theoretical, methodological, and contextual bases of public policy.		
Credit Seminars	Student-led exploration of a policy topic in consultation with guide, potentially contributing to the PhD thesis.		

Elective Courses			
Department Electives	Courses offered by the Centre that allow students to explore specialised policy areas aligned with their interests. They are typically 6-Credit courses but also include three-credit Skill-based Courses offered by the Centre.		
Institute Electives	Interdisciplinary courses offered by various academic units across IIT Bombay, open to all students, subject to the condition that they should be opted from outside the list of courses offered by ADCPS.		

Mandatory Non-Credit Courses (Pass/Not Pass)				
Communication Skills (PS 899)	The Communication Skills course is a Pass (PP)/Not Pass (NP) requirement to be completed within the first two semesters. It does not count toward minimum credit requirements, but clearing it (with a PP grade) is mandatory for degree award.			
Gender in the Workplace (GC 101)	A compulsory core non-credit course sensitising students to gender issues and workplace ethics, administered by the Gender Cell.			
TASET (TA 101)	TASET program is an orientation and skill-building program to prepare Teaching Assistants.			

	Audit Courses			
Audi	it Course	Audited courses allow exposure to a subject without formal grading and appear on the transcript with an 'AU' grade if minimum participation requirements are met, and if unmet, it is considered as dropped and does not appear on the transcript. They do not count toward credit or CPI/SPI calculations. Students may opt to Audit up to two courses per semester with prior instructor approval.		

Additional Learning Courses			
Additional Learning	Students may take extra courses as Additional Learning beyond credit requirements. These do not affect SPI/CPI but appear on the transcript with actual grades.

Note: 1. Institute Elective (IE) should be opted from outside the list of courses offered by ADCPS. In other words, courses with code PS XXX cannot be opted to fulfil the Institute Elective credit requirements. Department Electives are the courses offered by ADCPS. It is suggested that the Elective Courses be opted in consultation with potential research

guides. Elective courses could be pursued in any of the two semesters during the duration of course work in the first year since joining.

2. Admitted PhD students with MA in Public Policy have to fulfil a minimum of 42 credits. It includes the following as mandatory courses: PS 609, PSS 801, PS 633, PSS 802, two Department Electives and one Institute Elective.

### 3.5. Confirmation of PhD Registration

For confirmation of PhD registration, students are required to complete the required course work, as per the applicable requirement mentioned in the rules. Students are required to submit the PhD confirmation form within 15 days from the date of registration of the semester following the completion requirement of course work.

The date of confirmation to PhD will be the date of registration of the following semester after successful completion of the required course work. Confirmation to PhD is necessary for: (i) Temporary break during the programme, (ii) Presynopsis report submission and presentation, (iii) Synopsis and Thesis Submission, and (iv) Availing Exit option from PhD programme.

Registration dates of all students shall be decided by the Postgraduate Academic Performance Evaluation Committee (PGAPEC). The final approval to the registration shall be granted by the Senate.

The procedure for confirmation of registration shall be as follows: i) Each student, on completion of the course requirements shall apply for the confirmation of registration. ii) The completed application form shall be forwarded to the PGAPEC, which will consider and confirm the date of registration according to the PhD rules (R.6.1 to R.6.8, as applicable).

## 3.6. Annual Progress Seminar

All PhD students are required to submit a report (APR – Annual Progress Report) and present a seminar (APS – Annual Progress Seminar), every year from the date of joining, to the Research Progress Committee (RPC) in consultation with supervisor and co-supervisor (if applicable) till successful completion of presynopsis. The APR should be submitted prior to the APS presentation.

Following are the schedules of APS presentations:

For students joining in Autumn semester: July to September of the year.

For students joining in Spring semester: December to February of the year.

Refer Institute Academic Calendar for specific dates of presentation.

Students are required to present a Biannual Progress Seminar (BPS), after completion of 6 yrs (for students in PhD programme)/7 yrs (for students in Dual Degree (Masters + PhD programme) till the successful completion of the presynopsis.

Extension of APS may be considered in exceptional cases only with prior permission. Application for extension must be submitted by the student using appropriate form through proper channel at least TWO WEEKS prior to the expiry of the APS schedule. Late fine of Rs. 750/- per week will be applicable for delay in APS presentation.

# **Information on Financial Support**

### 4.1. Fellowships & Assistantships

- PhD students admitted in the Teaching Assistantship (TA) category will receive a monthly fellowship. The eligibility criteria for awarding TA positions for PhDs are according to the guidelines determined by IIT Bombay.
- PhD students admitted in the Financial Award (FA) category, national-level scholarships and sponsorships can be availed from the central and state governments, subject to fulfilling the required eligibility criteria.
- PhD students are also admitted for the Teaching/Research Assistantships through Project (TAP/RAP) depending upon project availability.

## 4.2. Financial Support for International Conferences

Two types of financial support are offered: 1) Financial Assistance and 2) Refundable Advance.

The financial support is inclusive of the following:

- Travel
- · Registration fees
- DA (including local travel, food bills and local stay as given below)

# **Leave Policy**

According to the PhD Rules at IIT Bombay (Please see Section 11, pp. 45-46):

- All Research Scholars under Teaching Assistantship (TA)/Research Assistantship (RA)/Self-Finance (SF) categories are entitled for leave for a maximum of 30 days per year in addition to public holidays. Also 10 days leave on medical reasons is permitted. The leave due can be carried over to the next year and accumulated upto 90 days.
- Women Scholars are entitled for maternity leave at the full rate for a period of not exceeding 180 days, once during the tenure of their studentship. This should be supported by a medical certificate.
- Male Scholars are entitled for 15 days paternity leave once during the tenure of their studentship. This should be supported by a medical certificate.
- The Head of Department/ Academic unit/ Convener of the Interdisciplinary Programme is authorised to sanction the above leaves.
- No vacation in Summer/Winter is admissible.
- Special Leave to attend Seminars/Conferences in India/abroad to present research papers is admissible as follows:

Internship	Upto 6 months during the entire tenure of the PhD programme.	No	Convener, DPGC (in consultation with DPGC)

Note: Academic leave in excess of above shall be considered by the Dean (AP) on the recommendation of the Convener, DPGC.

 Research Scholars under CSIR/UGC and other categories are governed by the rules of the bodies which provide financial support. In absence of specific rules of the funding agencies the students shall be governed by the Institute leave rules.

## **Ethics Clearance for Fieldwork**

Students whose research work involves human participation (either directly or indirectly), should obtain IIT Bombay Institute Ethics Committee (IEC) approval prior to start of the study or the component of the study involving human participation. IEC approval is mandatory for all such projects. In fact, this is mandated by several funding agencies also e.g. DST, DBT, CSIR and ICMR. IEC approval is also a pre-requisite for such research work to be published in peer reviewed journals of repute. IEC approval cannot be taken retrospectively (Please see: R 8.6, p. 37, PhD Rules).

Note: This aspect in usual cases is not applicable to the type of fieldwork done by PhD students at ADCPS. Yet, it is recommended that the possibilities be consulted with the Research Guide, Faculty Advisor and Head of Department.

## **Student Wellness**

After securing admission at the Institute and starting your stay here, you may feel that a lot of parameters around you are different. You would have more responsibilities to handle at the hostel and at the academic level. Take heart, you will not be the only one. There are a few issues that almost everyone in the Institute faces initially, like academic concerns, social (family and peer) pressure, etc, leading to feelings of loneliness, low confidence, anxiety, stress, anger and sadness, to name a few. It is important to understand that students often lose their focus and give in to these pressures. If not attended to at the right time, this could lead to poor performance, both academically and personally. To help you refrain from losing focus and being unhappy, Counsellors at the Institute-level Student Wellness Centre encourage you to approach them for any problem that you are facing - be it academic, emotional, social or financial-without hesitation.


