## **1.3. Mission**

To encourage a sustained dialogue between academia and other policy stakeholders in order to promote evidence informed and inclusive policy making and analysis; and create capacity for policy studies in the country.

## **1.4. Public Policy at IIT Bombay**

The Ashank Desai Centre for Policy Studies (ADCPS) at the Indian Institute of Technology (IIT) Bombay offers a rigorous and interdisciplinary environment for advanced education and research in public policy. Through its Master of Public Policy (MPP) and Doctoral (PhD) programmes, the Centre engages with complex policy problems by drawing on integrated perspectives from the fields of Social Science, Law, Science, Engineering, and Medicine. Its academic and research focus is organised around five core thematic areas: (i) **Digital Society & Governance**, (ii) **Social Policy (Education, Ageing, Identity)**, (iii) **Technology & Policy**, (iv) **Urban Policy**, and (v) **Water, Sanitation, Energy, Climate Change**.

Embedded within one of India's premier institutions, ADCPS equips scholars with strong analytical capabilities, methodological foundations, and applied experience to contribute meaningfully to policy research, governance, and institutional practice. The programme is committed to fostering thoughtful, evidence-informed, and contextually grounded approaches to public decision-making in India and globally.

# The Institute and its Legacy

## 2.1. About the Institute

IIT Bombay, established in 1958, is one of India's most respected institutions for higher education and research. Created through a national initiative with early support from UNESCO and the former USSR, the institute was declared an *Institute of National Importance* under the Institutes of Technology Act, 1961.

The residential campus spans over 500 acres nestled in Powai between Vihar and Powai lakes and adjacent to the Sanjay Gandhi National Park, offering a lush green and tranquil environment conducive for focused academic pursuit and fulfilling campus life. The institute offers a comprehensive residential experience, with well-equipped hostels, dining halls, sports complexes, and recreational amenities.

Academically, IIT Bombay attracts some of the brightest students in the country and maintains high standards through its distinguished faculty, many of whom are recipients of national honours. In addition to undergraduate, postgraduate, and doctoral programmes, the institute is a leader in offering innovative continuing education, short-term certificate courses, and distance learning programmes. At present, IIT Bombay comprises 17 academic departments, eight degree awarding centres which includes ADCPS, three schools including Shailesh J. Mehta School of Management (SJMSOM), IDC School of Design, and Desai Sethi School of Entrepreneurship, and over 35 specialised research centres, supporting together over 13,000 students and 1000+ faculty across engineering, sciences, humanities, social science, management, design, and policy.

What sets IIT Bombay apart is not only its disciplinary strength but also its interdisciplinary depth. Faculties and research centres routinely collaborate across domains, bringing together insights from technology, social science, design, and management. Schools/Centres like the SJMSOM, Centre for Technology Alternatives for Rural Areas (C-TARA), ADCPS, IDC School of Design, and the Department of Humanities and Social Sciences (HSS) make this convergence possible and productive.

The institute combines rigorous academics with vibrant extra-curriculars boasting active student bodies like the Gymkhana, cultural festivals such as Mood Indigo, flagship technology events like TechFest, sports complexes, and rich club activities. It also features cutting-edge research infrastructure, a central library, and extensive sports and student-activity facilities, nurturing a holistic learning ecosystem. Designated as an *Institution of Eminence* in 2018, IIT Bombay

excels in industry collaborations, international exchange, leadership in innovation, development of future-ready professionals, and enjoys a legacy of its prominent global footprint.

## 2.2. About the Centre

The **Centre for Policy Studies (CPS)** at IIT Bombay was established in 2016 to advance rigorous research, interdisciplinary teaching, and public engagement in the field of public policy. Conceived as a centre for research, education, training, and practice, its founding responds to the growing national and global demand for policy professionals capable of navigating the complex intersections of governance, technology, economy, and equity in a deeply interconnected world.

The Centre began its academic journey with the launch of its PhD in Public Policy programme in 2017, followed by the Master of Public Policy (MPP) in 2019. In 2021, it was renamed as **Ashank Desai Centre for Policy Studies (ADCPS)** in honour of Mr Ashank Desai, an IIT Bombay alumnus and philanthropist, whose generous support has helped strengthen the Centre's vision and capacity. Both programmes aim to develop public policy professionals and scholars who combine analytical depth with contextual sensitivity, capable of leading and serving across government, civil society, academia, multilateral organisations, and industry.

ADCPS recognises that public policy today extends well beyond statecraft and bureaucracy; it shapes and is shaped by civil society, the private sector, and academic institutions. The Centre therefore equips students with the tools to engage across diverse fields and real-world contexts, fostering the ability to adapt, interpret, and influence policy in areas such as health, education, technology, urban development, labour, and sustainability. These programmes also leverage IIT Bombay's broader institutional strengths to establish ADCPS as a national hub for public policy expertise that bridges social sciences, governance, and technological innovation.

Embedded within one of India's premier institutes of science and technology, ADCPS is uniquely positioned to explore public policy at this interdisciplinary nexus. Its faculty bring academic training from globally reputed institutions and expertise spanning economics, law, engineering, environment studies, sociology, urban studies, political science, and digital cultures. Their research covers themes such as Artificial Intelligence (AI) and labour, platform economies, environmental governance, water policy, education, housing, digital infrastructure, and public health thereby generating impactful scholarship with practical relevance. See **Appendix 2.2** for the full faculty list and their areas of research.

ADCPs structures its research and teaching around five core thematic areas:

- (i) **Digital Society & Governance**, investigating the intersections of physical and digital spaces through research on infrastructure, platform design, regulation, information commons, and the evolving roles of media, social media, and digital governance;
- (ii) **Social Policy (Education, Ageing, Identity)**, foregrounding intersecting inequalities across gender, caste, religion, region, sexuality, age, and political identity and advocating more inclusive and accountable policy frameworks;
- (iii) **Technology & Policy**, examining how technological systems and public policy co-evolve, across domains such as agriculture, healthcare, urban systems, public opinion, and surveillance;
- (iv) **Urban Policy**, addressing challenges of infrastructure, housing, employment, and basic services in India's rapidly urbanising landscape, while informing policies for inclusive, sustainable, and livable cities;
- (v) **Water, Sanitation, Energy, Climate Change**, re-positioning environmental concerns as gateways to broader cross-sectoral policy questions, and promoting interdisciplinary approaches grounded in care, inclusion, and sustainability.

These research themes are supported by an active engagement with engineering, design, political theory, legal reasoning, and institutional economics, equipping students to critically examine public issues and design grounded solutions. Graduates of ADCPS are envisioned to go on to shape policy in government, multilateral institutions, NGOs, academia, and the private sector, bringing with them a combination of analytical rigour, ethical clarity, and contextual sensitivity.

The Centre's **Advisory Board** includes prominent thought leaders such as Ashank Desai, Kaushik Basu, Arun Maira, Yamini Aiyar, and Harish Hande, who guide its long-term priorities (see [Appendix 2.1](#)). Beyond the classroom, ADCPS sustains a vibrant public presence through seminars, workshops, conferences, Policy Talks, Policy Dialogues, Policy Briefs, Working Paper Series, Policy Roundtables, and its Talking Policy blog series. An elected student body plays a proactive role in shaping student life at the Centre, coordinating communication, placements, cultural and sports events, and other student-led initiatives (see [Appendix 2.4](#)).

As ADCPS welcomes the **seventh cohort** of its MPP programme in 2025, it continues to grow as a platform where academic rigour meets public relevance,

committed to nurturing policy professionals and scholars who are as attentive to democratic values as they are to structural realities and global transformations.

## **2.3. Programmes Offered**

ADCPS currently offers two flagship academic programmes:

**Master of Public Policy (MPP):** A two-year interdisciplinary postgraduate programme designed to equip students with analytical, methodological, and conceptual tools necessary for policy design, implementation, and evaluation. The MPP blends theoretical grounding with practical training, enabling graduates to engage effectively across government, civil society, industry, international organisations, and academia.

**PhD in Public Policy:** A research-intensive doctoral programme aimed at fostering scholarship that addresses pressing policy questions with rigour and contextual sensitivity. The programme welcomes scholars from diverse disciplinary backgrounds and supports critical inquiry across a wide range of policy domains.



# MPP Programme Overview

Master of Public Policy (MPP) at the ADCPS, IIT Bombay is a two-year, full-time residential postgraduate programme designed to equip students with the strong conceptual foundations, analytical skills, practical tools, and interdisciplinary perspectives to engage meaningfully with today's complex policy challenges. The programme aims to produce professionals who are not only intellectually rigorous but also attuned to real-world governance and public interest. Students are trained to take up roles in government, consulting, international organisations, think tanks, civil society, and academia, among others<sup>1</sup>.

## 3.1. Journey through the MPP Programme



The Institute follows a credit-based semester system with two regular terms each year. The **Autumn Semester (Semester 1 & 3)** runs from July to November, and the **Spring Semester (Semester 2 & 4)** runs from January to April.

Semesters 1 and 2 emphasise theoretical grounding through core courses in public policy theory, and research methods. Elective courses (both departmental and institute-wide) enable students to expand their disciplinary range and begin developing domain-specific expertise.

In Semester 2, students take a 4-credit seminar course that allows exploration of a policy topic of interest. Guided by a faculty supervisor, students conduct

literature reviews and frame research questions, culminating in a group presentation. The seminar often lays the groundwork for MPP Thesis 1 and helps identify relevant internship opportunities just after the semester. *Tip: Think of the Seminar as a mini project where you develop a term paper with a detailed literature review that can evolve into your MPP dissertation.*

During the summer break between Semester 2 and 3, students undertake an **8-week internship<sup>2</sup> (20 credits)** aligned with their research interests, which is jointly planned by the student and their faculty supervisor. Students are expected to regularly update their supervisors and submit a detailed report. On returning to campus, students must present their internship experience and demonstrate how it contributed to shaping their MPP dissertation. The report must be submitted at least one week before the presentation, which is evaluated by faculty and representatives from the host organisation.

In Semester 3, soon after the internship presentation, students finalise their research topic in consultation with a faculty supervisor. This is the beginning of **MPP Thesis 1**. The first phase of MPP Thesis primarily focuses on developing an in-depth understanding of the chosen policy field and sets the ground for empirical research. A comprehensive review of literature, theoretical framework, research question and methodology are the major components of Thesis 1 along with a fieldwork plan proposed for MPP Thesis 2. Students are also encouraged to take skill-based and competency-driven electives during this semester. During the winter break, students are expected to do their fieldwork and start analysis.

In Semester 4, students continue with their **MPP Thesis 2** which involves conducting empirical research, analysis, and writing of the final thesis and policy brief. The draft proposal for MPP Thesis 2 shall take place in the month of February. Students shall present the draft and final submissions to internal and external reviewers as per the department scheduled timeline for the final semester.

### **3.2. Course Credit Structure and Curriculum**

The MPP curriculum is structured across four semesters, with a balance between theoretical coursework, field engagement, and intensive research. The programme emphasises a progressive build-up of conceptual, analytical, and empirical competencies for which several meticulously designed courses are offered. ### 3.2.1. What are Course Credits?

Credits are determined by weekly contact hours i.e. each weekly hour of Lecture (L) or Tutorial (T) counts as 2 credits, and each weekly hour of Practical (P) counts as 1 credit. For example, a course 'X' with 2 hours of Lecture and 1 hour of Tutorial per week would carry  $[(2 \times 2) + (1 \times 2) + (0 \times 1)] = 6$  credits. Courses are typically denoted in "L-T-P-C" format; hence, course 'X' would be listed as '2-1-0-6' indicating weekly 2 hours of Lecture, 1 hour of Tutorial, 0 hours of Practical, and a total of 6 credits. In simple terms, 1 credit means 7 contact-hours (teaching hours).

### 3.2.2. What are the Different Types of Courses while Registering?

Mandatory Credit Courses	
Core Courses	Foundational and mandatory courses required by the Centre, covering theoretical, methodological, and contextual bases of public policy.
Seminar Course (PS 694)	Student-led exploration of a policy topic under faculty supervision, forming a base for the theses.
Internship (PS 621)	An 8-week internship undertaken during the semester break between semester 2 and 3, aligned with the student's research interest and intended to support their MPP thesis work. Evaluation includes a presentation and written report.
Thesis 1 (PS 796)	MPP Thesis 1 (18 credits): Development of research design, questions, and methodology. Marks a formal beginning of the thesis (Semester 3).
Thesis 2 (PS 798)	MPP Thesis 2 (40 Credits): Fully dedicated to empirical research, data collection, analysis, and final writing. Students also prepare and present a policy brief. Evaluated by internal and external reviewers (Semester-4).

Elective Courses	
Department Electives	Courses offered by the Centre that allow students to explore specialised policy areas aligned with their interests. They are typically 6-Credit courses but also include three-credit Skill-based Courses offered by the Centre (See Appendix 3.1).
Institute Electives	Interdisciplinary courses offered by various academic units across IIT Bombay, open to all students subject to limitation that it should not be closely allied to a student's own discipline (typically interpreted that it should be offered by an academic unit other than one's own) (Refer MR 1.3).

Mandatory Non-Credit Courses (Pass/Not Pass)	
Communication Skills (PS 899)	The "Communication Skills" is a compulsory Pass/Not Pass (PP/NP) course requirement to be completed within the first two semesters. It does not count toward minimum credit requirements, but clearing it (with a PP grade) is mandatory for degree award (Refer: MR2.2A).
Gender in the Workplace (GC 101)	A compulsory core non-credit course sensitising students to gender issues and workplace ethics; administered by the Gender Cell (Refer: MR 4.12).
TASET (TA 101)	TASET program is an orientation and skill-building program to prepare Teaching Assistants (TAs) for their responsibilities and potential challenges (Refer: MR. 4.13).

Audit Grade Courses	
Audit Course (AU)	Audited courses allow exposure to a subject without formal grading and appear on the transcript with an 'AU' grade if minimum participation requirements are met, and if unmet, it is considered as dropped and does not appear on the transcript. They do not count toward credit or CPI/SPI calculations. Students may opt to audit up to two courses per semester with prior instructor approval (Refer: MR 4.3).

Additional Learning (AL) Courses	
Additional Learning (AL)	Students may take extra courses as "Additional Learning" beyond credit requirements. These do not affect SPI/CPI but appear on the transcript with actual grades. The "Additional Learning" tagged courses can be re-tagged only once as "Department/ Institute Elective" and vice versa (except for Core courses, which cannot be re-tagged) (Refer: MR 4.4).

### 3.4. Ethics Clearance for Research

As per MR 10.0 of the IIT Bombay Master's Rules, students conducting research involving human participants, whether directly or indirectly, must obtain prior approval from the Institute Ethics Committee (IEC) before beginning their study. This includes interviews, surveys, fieldwork, or any data collection involving human subjects. Retrospective approval is not permitted.

IEC approval is mandatory for compliance with research ethics, institutional policy, and the requirements of most funding agencies (e.g., DST, DBT, CSIR, ICMR), and it is essential for publication in reputed journals. Students must plan their research timelines accordingly and consult their supervisors early to initiate the IEC process.

# Financials & Administration

## 4.1. Fee Structure

MPP students at IIT Bombay are required to pay tuition and other semester-wise charges in accordance with the Institute norms. The latest fee structure is available on the official IIT Bombay website: <https://acad.iitb.ac.in/admissions/fees-structure>. Timely payment is essential, as delays may incur daily late fees and may also block registration for the subsequent semester.

## 4.2. Fellowships & Assistantships

Institute Teaching Assistantships (TAs) are awarded to eligible students, typically in Category TA. These students receive a monthly stipend as per MHRD norms. External fellowships (FAs) (e.g., through UGC, CSIR, DST etc.) may also be available to eligible students. MPP students at ADCPS typically may be registered under any of the following categories<sup>3</sup>:

**Teaching Assistantships (TA):** ~12 positions are offered annually. A valid GATE score is required.

**Fellowship Award (FA):** Open to those with fellowships from government/semi-government agencies (e.g. CSIR, UGC<sup>4</sup>, DST). A valid JRF award letter is needed.

**Project Assistantships (TAP/RAP):** Offered based on availability. Valid GATE score required.

**Self-Finance (SF):** Open to in-service candidates and those with work experience. Fresh graduates require a valid GATE score and must have completed their UG degree at least 2 years prior to admission.

**Sponsored (SW):** GATE score not required if candidate has 2+ years of experience; otherwise, GATE is mandatory.

## 4.3. Other Financial Assistance

IIT Bombay is committed to ensuring that no student admitted to the Institute is denied the opportunity to pursue their education due to financial constraints. In line with this commitment, a variety of financial assistance schemes are available. These include the Institute-level Financial Aid Programme (FAP), the Student Benevolent Fund managed by the Office of the Dean (SA), laptop loans, and easier term bank loans, among others. Academic Office or the Department Office. The department facilitates internship placement processes and academic oversight but does not provide financial support beyond Institute provisions.

## 4.5. Vacation & Leave Policy

According to IIT Bombay's Master's Rules (MR 9 - p35, PGPC 232nd Meeting),

**Winter and Summer Breaks:** "Students admitted for 2 years master programme are entitled for Winter vacation in December and Summer break (15 days) in their first year."

**Personal Leave:** In addition to public holidays, students are "entitled for a maximum of 30 days leave in addition to public holidays, during the entire tenure of the programme."

**Academic Leave (Conferences/Seminars):** Up to 5 working days per semester are permitted for academic events related to coursework or research. These are leave-with-stipend, approved by the Head of Academic Unit.

Additional leave requires approval from the Dean (AP) upon the recommendation of the DPGC Convener.

## 4.6. Convocation & Exit Formalities

Before leaving campus, all graduating students must complete exit formalities, including submission of no-dues certificates and necessary settlements. No-dues are to be obtained from the Academic Office, Dean (SA), Department Office, Estate Office, Gymkhana, HCU, Library, SAU, and Electronic Thesis and Dissertation (ETD). The department office will guide you through this process.

For students submitting a thesis, it is mandatory to upload Thesis 2 and the Policy Brief to the Library's ETD repository. To register for convocation, log in to the ASC portal: <https://portal.iitb.ac.in/asc>

**Prerequisites to fill the convocation form:**

- (i) Completion of graduation requirements (including course tagging and thesis defence).
- (ii) Thesis submission approved by your supervisor and validated on the ETD portal (for MPP and PhD students).
- (iii) Payment of the convocation fee of ₹500 via the online payment gateway. Once payment is successful (you receive a “Successful Transaction” message), you may proceed to fill out the convocation form.






### 5.1.3. Outbound Exchange Programmes

Student Exchange Programmes enable students of IIT Bombay to study in institutions from different corners of the globe by offering students the opportunity to spend one or two semesters abroad for coursework or research under established MoUs with international universities. Students must plan ahead, ensure academic alignment, and secure necessary approvals. Most exchanges are self-funded, though some offer scholarships or support. For detailed guidelines, eligibility, timelines, updates, and application procedures, please visit the Dean IR (International Relations) website: <https://www.ir.iitb.ac.in>.

### 5.1.4. Conversion to Dual Degree PhD Programme

Motivated MPP students subject to eligibility may apply for conversion to a Dual Degree (MPP + PhD) programme without needing to undergo a separate PhD admission process. The option is available from the 3<sup>rd</sup> semester onwards, and applications must follow the official institute schedule as per the Institute guidelines<sup>5</sup> and may require some pre-planning.

**Eligibility:** Students must have registered the required MPP coursework and follow the department's timeline for submission of the application and evaluations. A valid research proposal (RP) is mandatory at the MTP-I (thesis 1) stage; successful presentation with an "AB" grade or higher in MTP-I is required. Alternatively, conversion may be sought at the MTP-II (thesis 2) stage via oral evaluation.

#### Degree Decoupling Option (Only for MTP-I stage applicants):

**With Decoupling:** Students may complete and receive their MPP degree upon finishing Master's requirements, followed by the PhD upon completion of doctoral work. MTP-II (thesis 2) must be completed and evaluated.

**Without Decoupling:** Both MPP and PhD degrees are awarded together at the end of the PhD programme. MTP-II (thesis 2) is not required in this case, but all other credit requirements must be completed.

**No Extra Coursework:** Students admitted through conversion are not required to do additional coursework beyond the MPP requirements.

**APS & Registration:** The first APS for PhD is the Research Proposal or MTP-II (thesis 2) evaluation (R.8.2 of PhD Rules<sup>6</sup> - Ref 233/260 Senate Meeting). Students must register as PhD scholars in the semester following the conversion and PhD rules will apply henceforth.

**Assistantship:** Eligible students may receive a PhD assistantship after conversion, subject to relevant norms and cumulative period.

**Exit Option:** Students may apply to exit the programme early with either one or both degrees (MPP and MS by Research), based on research progress, departmental recommendation, and Institute approval (refer guidelines for more as referenced).

### 5.1.5. Award of 'Minor' Degree with the Masters

An “important feature (of Masters Programmes at IIT Bombay) is the concept of a ‘minor’ wherein a student can utilise electives into a focused group of courses in another discipline”. A minor will consist of 18-24 course credits. “This may include a maximum of 6 credits of R&D project. The Programme committees are required to prescribe and approve the structure of the minors to be offered” (MR, p.9; 247th Senate Meeting). 


